

# EVALUATION SUMMARY

### U.S. Fulbright Scholar Program Outcome Assessment

*The purpose of the evaluation was to assess and document the outcomes and impact of the U.S. Fulbright Scholar Program. Specifically, to 1) ascertain – in quantitative and qualitative terms – whether the program is achieving its legislative goals; 2) assess the broader impacts of the program on individuals and institutions both in the United States and in the Fulbright Scholars' host countries; and 3) assess and document the contribution of the "Fulbright Scholar experience" to the professional and personal lives, activities and achievements of program alumni.*

### Key Findings

#### ➤ **Serving the National Interest and Promoting Mutual Understanding**

*Since completing the grant*

- 75 % of Scholars have continued to collaborate with host country or institution colleagues
- 70 % have initiated professional exchanges of people
- 70 % have been visited in the United States by host country colleagues or friends
- 60 % have revisited their host country with over 40 % returning to participate in conferences or seminars

#### ➤ **Impact on the Individuals and Institutions**

- 100 % reported the experience gave them a deeper understanding of the host country
- 98 % interacted with people from their host country through media, community or other activities outside of their professional responsibilities
- 73 % of Scholars have incorporated aspects of the Fulbright experience into courses and teaching methods
- 76 % gave papers or presentations at scholarly or professional meetings
- 71 % published in refereed journals
- 51 % have become more involved with colleagues from other countries

#### ➤ **Perceived Value of the Program**

- 98 % of Scholars found the program to be valuable
- 97 % are proud to have been a U.S. Fulbright Scholar
- 88 % would like to obtain a second grant

**Project Information:** SRI International (formerly the Stanford Research Institute) conducted the study from September 1999 through April 2002. SRI surveyed a stratified random sample of 1,004 U.S. Fulbright Scholar alumni whose grants began between 1976 and 1999. Scholars were notified of the survey by e-mail, and a total of 801 alumni – 80 percent – completed the questionnaire either on the Web or by hard copy.
